GOLDING ESSAY PRIZE 2020

The CLA is offering a prize of £1000 to be awarded for an essay submitted by a student, trainee solicitor, pupil barrister, devil barrister (from Scotland) or trainee patent and trade mark attorney on the following topic:

Are the courts of England & Wales right to consider plausibility in so many contexts as part of their validity analysis? What is the legal basis for their approach and what are the potential consequences?

In the foreword to the 18th edition of Terrell on the Law of Patents, which for the first time included reference to the concept of plausibility, Mr Justice Birss commented that: "The emergence of ... [plausibility] (or rather arguments about an alleged lack of it) in relation to each of inventive step, sufficiency and industrial applicability represents a significant recent legal development in the life sciences". Where did it emerge from, and should its emergence be welcomed?

The essay shall be of a maximum length of 5000 words (inclusive of footnotes) and the closing date for submission of entries is 29 February 2020. Entries should be formatted on A4 in at least 11 point font and 1.5 spacing with footnotes at the bottom of the page, and submitted in electronic form to the CLA secretary, Sharon Horwitz at sharon.horwitz@cma.gsi.gov.uk.

Entrants should please place a codeword instead of their real name on the essay and include both the codeword and real name, with confirmation that the author satisfies the entry qualifications, in the covering email.

Those already qualified as lawyers whether in the United Kingdom or a foreign jurisdiction are not eligible for the prize and the entry qualifications apply as at 29 February 2020.
