Rachael Mulheron KC (Hon) is Professor of Tort Law and Civil Justice at the School of Law, Queen Mary University of London, where she has taught since 2004. Prior to this, she held academic positions at Law Schools at Notre Dame Australia, and Warwick University. Rachael's principal fields of academic research concern Class Actions jurisprudence, Tort law and Medical Negligence. Rachael undertakes extensive law reform and governmental implementation work in England, in her academic capacity. Rachael has advised a number of law reform commissions, government departments and NGOs on collective redress-related matters and in numerous areas of tort-related litigation. Her publications have been judicially cited in several jurisdictions, including Australia, Canada, England, New Zealand, Singapore, South Africa and Kenya. In December 2020, Rachael was appointed an Honorary Queen's Counsel for her services to law reform.

Belinda Hollway is the head of Scott+Scott London and specialises in acting for businesses and for classes of businesses and consumers who have suffered loss as a result of cartels and other forms of anticompetitive conduct. Belinda is currently acting for Michael O'Higgins, proposed class representative in a collective action in relation to the manipulation of the Foreign Exchange market, and for Mark McLaren, the class representative in a collective action on behalf of purchasers of new motor vehicles for loss suffered as a result of the cartel in the Maritime Car Carrier market.
