*The discussion will focus on a number of recent hot topics in competition litigation, in particular collective actions (including Rowntree v PRS, Stephan and Hammond v Amazon.com, Inc. and Others, Bulk Mail Claim Limited v Royal Mail, Justin Gutmann v London & South Eastern Railway Limited (Boundary Fares)) and recent cases dealing with proving and quantifying damages (including Cabo Concepts Ltd v MGA Entertainment (UK) Ltd, PSA Automobiles SA & Others v Autoliv AB & Others, Justin Le Patourel v BT Group plc, Granville Technology Group Ltd (in administration) v Infineon Technologies AG & Ors), both from legal and economic perspectives.*
