upon his retirement from the High Court will deliver this year's lecture:

"The Private Enforcement of Competition Law: Reflections upon its development, progress, and challenges"

Sir Peter Roth recently retired after 16 years as a judge of the High Court, sitting in the Chancery Division.

Between 2013-2021 he was President of the Competition Appeal Tribunal, and he returned as Acting President for 8 months in 2024-25. Sir Peter continues to sit as a part-time Chair in the CAT.

In 2021-22, Sir Peter served as President of the Association of European Competition Law Judges. Prior to becoming a judge, he was chair of the CLA from 2002-2009.

Sir Peter is also chair of the trustees of the Alliance for Lawyers at Risk, a charity supporting human rights lawyers at personal risk for their work in various parts of the world.
